## **Before submitting your application:**

### **Admissions Requirements**

Applicants must have a high school diploma or GED, must be at least 18 years of age and have legal status or residency in the United States at the time of enrollment. Some programs have additional specific academic requirements in order to be accepted into the program. Some programs require a criminal background check the results of which may impact acceptance into the program or your future ability to complete the program.

The university reserves the right to deny admission to an applicant when such action is deemed to be in the best interest of the applicant or the university.

The University does not accept applicants with violent or sexual felony convictions into its programs of study. Other applicants with a felony record may complete a Felony Conviction Appeal Form which is reviewed by a subcommittee of the University's Safety Committee. The subcommittee, whose decision is final, will determine the candidate's ability to move forward in the admissions process.

Hodges University does not discriminate based on race, color, religion, gender, sexual orientation, national origin, age, or disability in the provision of educational opportunities or employment opportunities and benefits. Hodges University does not discriminate on the basis of sex or disability in the education programs and activities that it operates, pursuant to the requirements of all applicable federal and state legislation and regulations including, but not limited to, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990. ### **Student VISA Requirements**

This form enables the applicant to apply for an F-1 student visa at the nearest U.S. Consulate or Embassy.
